Section 1. Grave fees for exclusive right of burial (ERB) – grave deed

Cremated remains earthen grave (25 years ERB, an extension of the ERB to 50 years may be purchased for double the fee)	£700.00
Cremated remains above ground vault for two interments Sanctum vaults 2000 - includes initial plaque with inscription up to 80 letters including spaces. Cremated remains plots on Rose Garden (Haverhill only), plot for up to two loose interments, rose bush and plaque (25 years ERB).	£700.00

Stillborn babies and children up to three weeks old (including non-viable fetuses). Please note depth for one interment only.	£58.00
Additional fee to prepare a grave to accommodate a coffin six feet 10 inches or more in length and 30 inches or more in width.	£88.00

Interment of cremated remains in an earthen grave (either loose or in a casket).	£240.00

All fees relating to a burial (either full or cremated remains) of a child under the age of 18 or a baby stillborn after 24 weeks of pregnancy will be claimed for by West Suffolk Council from the Child Funeral Fund (CFF) which is funded by Central Government.
