Wixoe Parish Meeting Section 109 Order 2025

Made 7 January 2025

Recitals

- (1) The parish of Wixoe is situated within the district of West Suffolk Council.
- (2) There is no separate Parish Council for Wixoe.
- (3) Section 109 of the Local Government Act 1972 provides that, on the application of the parish meeting of a parish not having a separate parish council, the district council may by order confer on the parish meeting any functions of a parish council.
- (4) On the 31st day of October 2024 Wixoe Parish Meeting resolved that an application be made to West Suffolk Council for an order conferring the following functions of a Parish Council on Wixoe Parish Meeting:
 - (a) Under the Local Government Act 1972
 - i. Section 111: Subsidiary powers of local authorities.
 - ii. Section 124: Acquisition of land by agreement by parish and community councils.
 - iii. Section 133: Provision of parish and community buildings.
 - iv. Section 137: Power of local authorities to incur expenditure for certain purposes not otherwise authorised.
 - v. Section 139: Acceptance of gifts of property.
 - vi. Section 140A: Insurance of voluntary assistants of local authorities.
 - vii. Section 222: Power of local authorities to prosecute or defend legal proceedings.
 - (b) Under the Highways Act 1980
 - i. Section 96: Powers of highway and local authorities to plant trees, lay out grass verges, etc.
 - ii. Section 274A: Contributions by parish or community councils.
 - (c) Under the Town and Country Planning Act 1990
 - i. Section 61F: Authorisation to act in relation to neighbourhood
 - ii. Section 61G: Meaning of "neighbourhood area".
 - iii. Section 62C: Notifying parish councils of applications under section 62A(1).
 - iv. Schedule 1 paragraph 8: Local Planning Authorities: Distribution of Functions.
 - (d)Under the Local Government and Rating Act 1997

- (1) This Order may be cited as the Wixoe Parish Meeting Section 109 Order 2025.
- (2) This Order shall come into force on the date it is made.
