Is there any possible justification for keeping them separate?</p>	<p>Noted. The neighbourhood area follows the line of the parish boundary. This is the recommended in neighbourhood planning guidance.</p> <p>The location for the waste hub is a separate issue and to date no firm location has been decided.</p> <p>The formal merging of the councils is a separate issue. St Edmundsbury and Forest Heath are working together to share and deliver services efficiently.</p> <p>No change to the neighbourhood area required as a result of the comments received.</p>

11/05/2016	J W Garbutt	<p>Thank you for your communication concerning the proposed designation of a neighbourhood area for Great Barton.</p> <p>As a local resident I am in favour of the Parish Council having the responsibility for preparing a neighbourhood plan.</p> <p>My main concern is that any plan prepared by the Parish Council may be arbitrarily overruled by St Edmundsbury Borough Council, and without consultation.</p> <p>The Borough Council may at any time impose planning obligations and directions such as the build of a higher number of housing units than the neighbourhood can reasonably accommodate. The development of the triangle of land east of School Road, which should be reserved for a new village centre, needs to be safeguarded from inappropriate planning targets and interventions.</p>	Noted. Once made (brought into legal force), neighbourhood plans are part of the statutory development plan. Applications for planning permission must be determined in accordance with the development plan, unless material considerations indicate otherwise. No change required.
