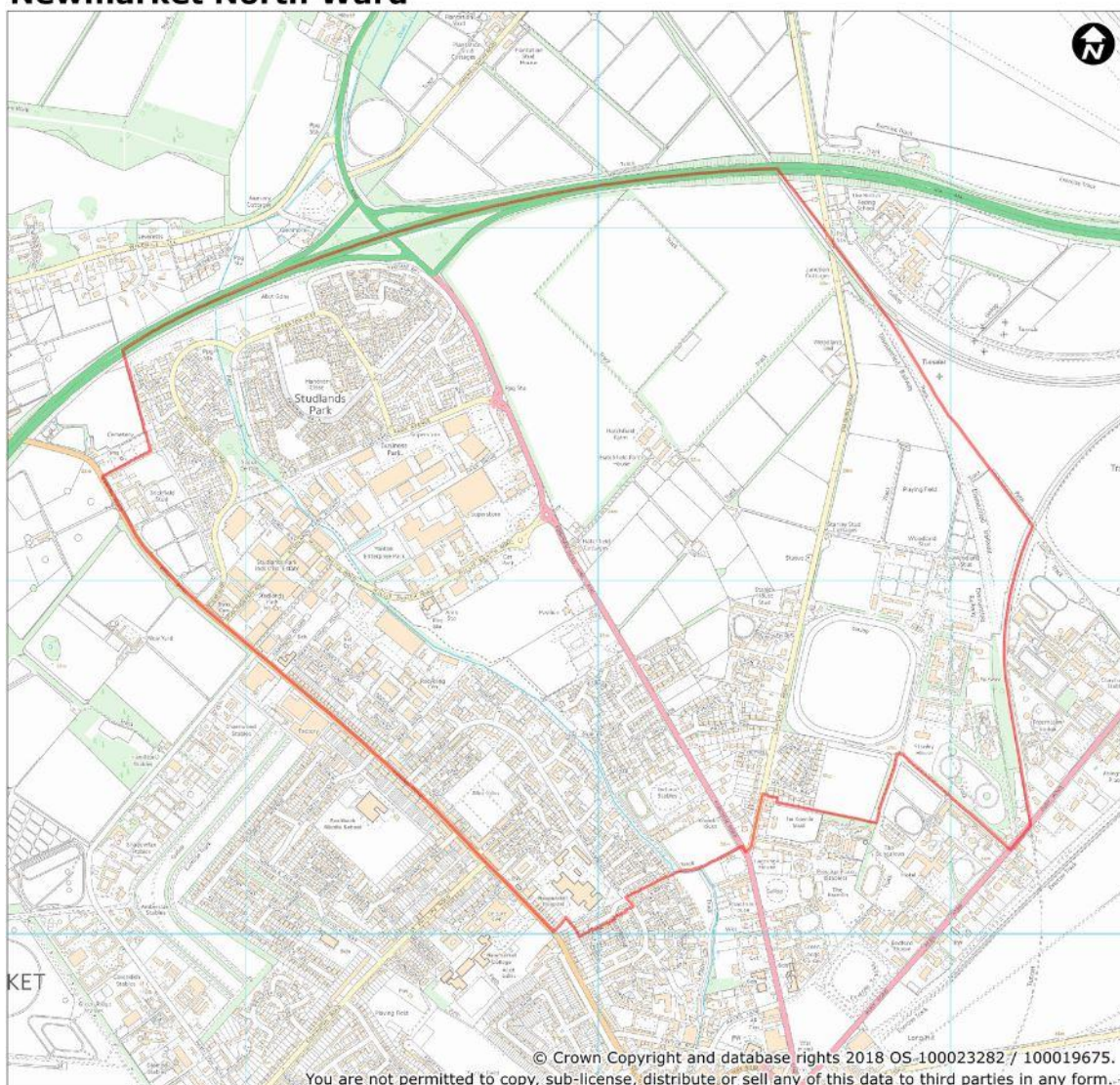


Ward report: Newmarket North ward

This report provides a snapshot of Newmarket North ward, using data that are available at Census Output Area or in some cases Lower Layer Super Output Area (LSOA) level. 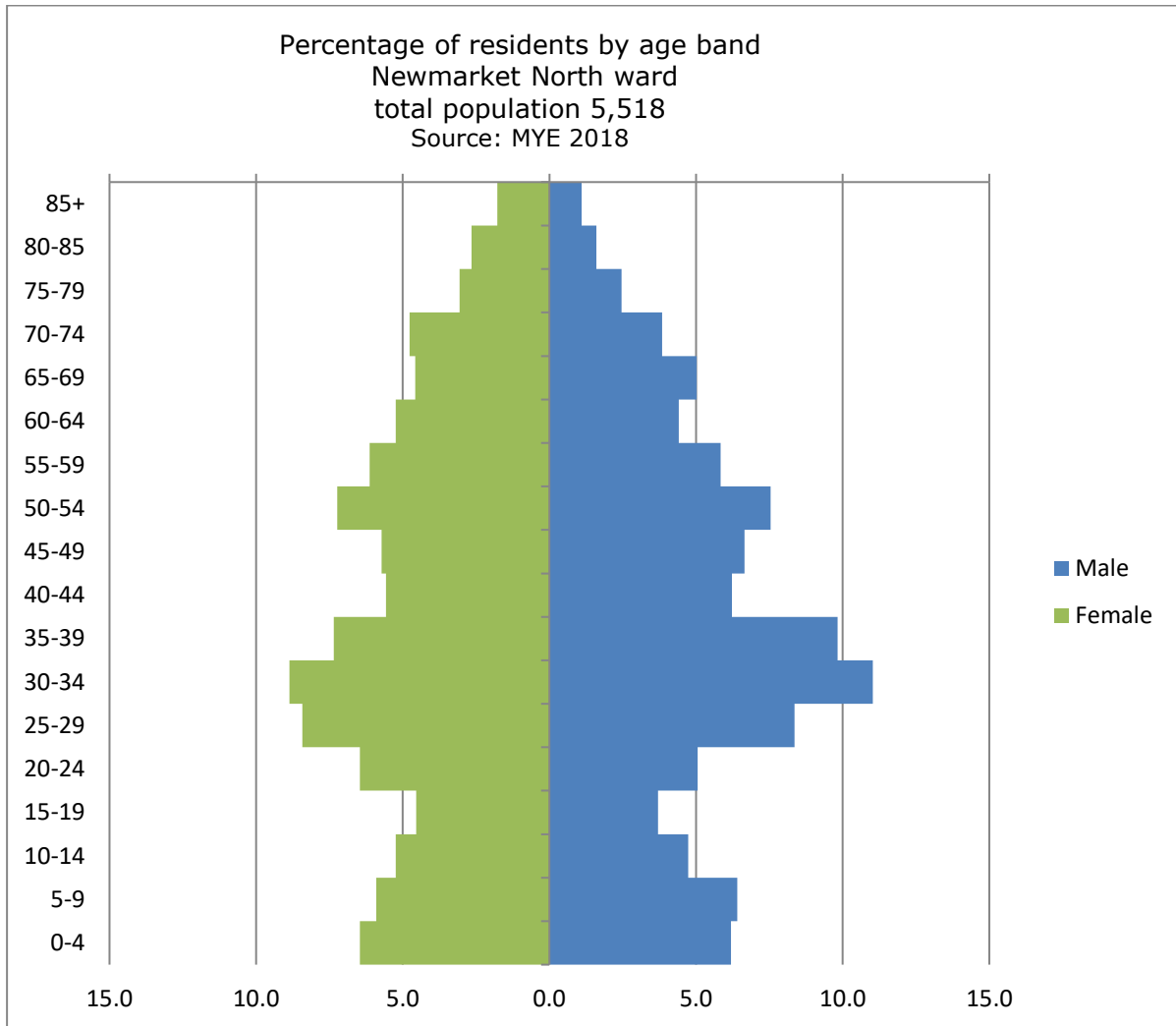
Population:

The number of residential dwellings in Newmarket North ward is 2,102. (Source: West Suffolk Local Land and Property Gazetteer, March 2019)

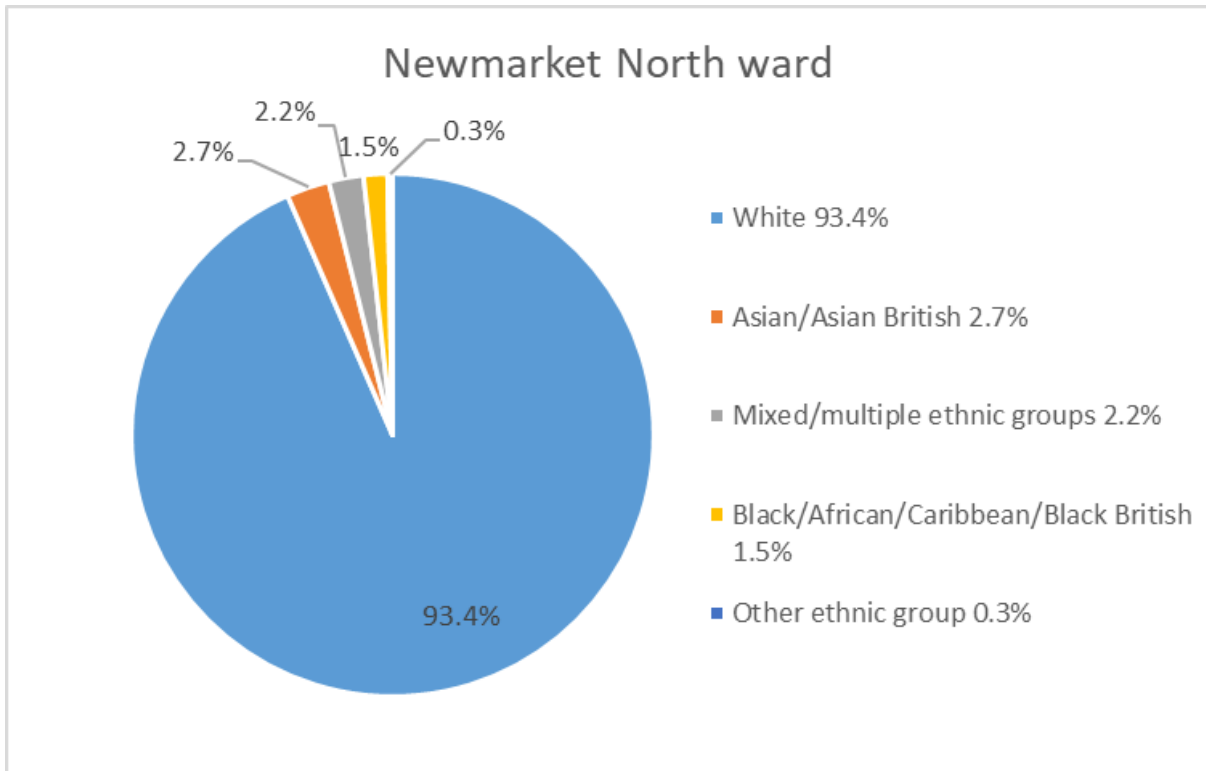

Newmarket North ward has a total of 343 businesses registered at Companies House (April 2019). 19 of these companies employ ten or more people. 46 companies have incorporation dates in the last year (April 2018 – April 2019) i.e. are businesses that have recently started up.

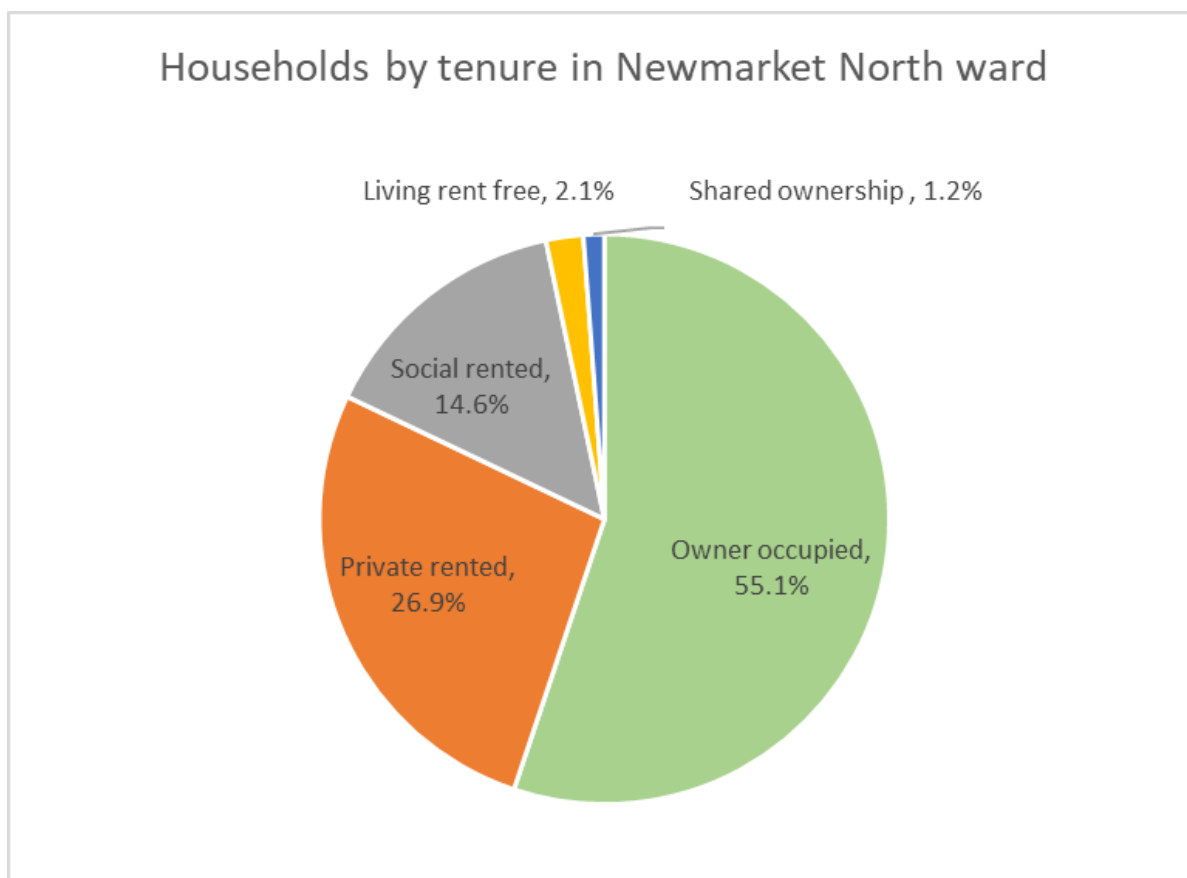

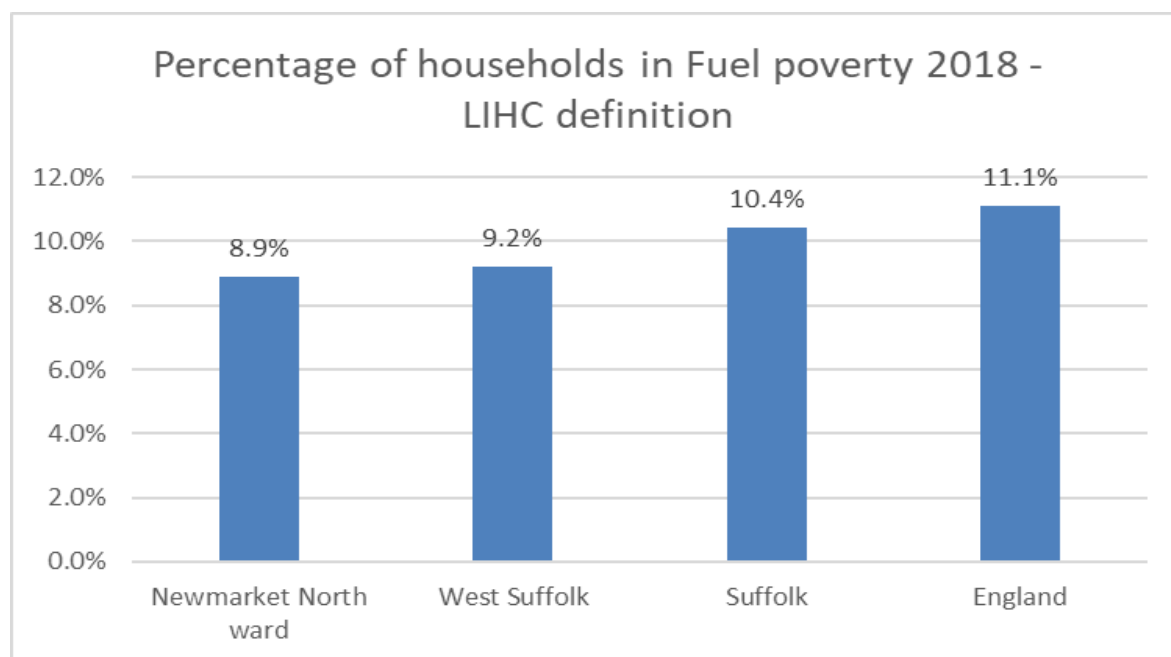
This table shows the median prices paid when homes were sold in the ward; how they compare to other areas; and how they have changed over time.

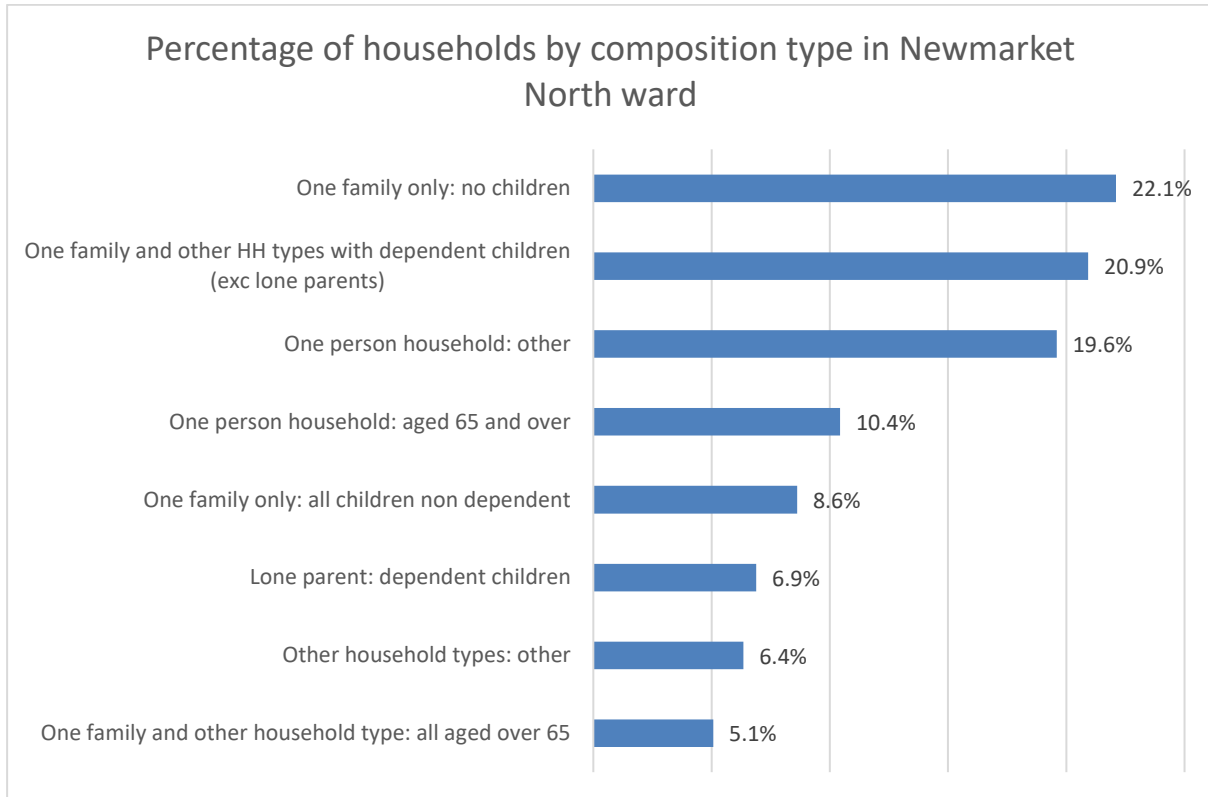
Fuel poverty: (source: Dept. for Business, Energy and Industrial Strategy. 2018 report with 2016 data. Data by LSOA)



Fuel poverty in England is measured using the Government's Low Income High Cost definition (LIHC), which considers a household to be in fuel poverty if: they have required fuel costs that are above average and were they to spend that amount they would be left with residual income below the poverty line.

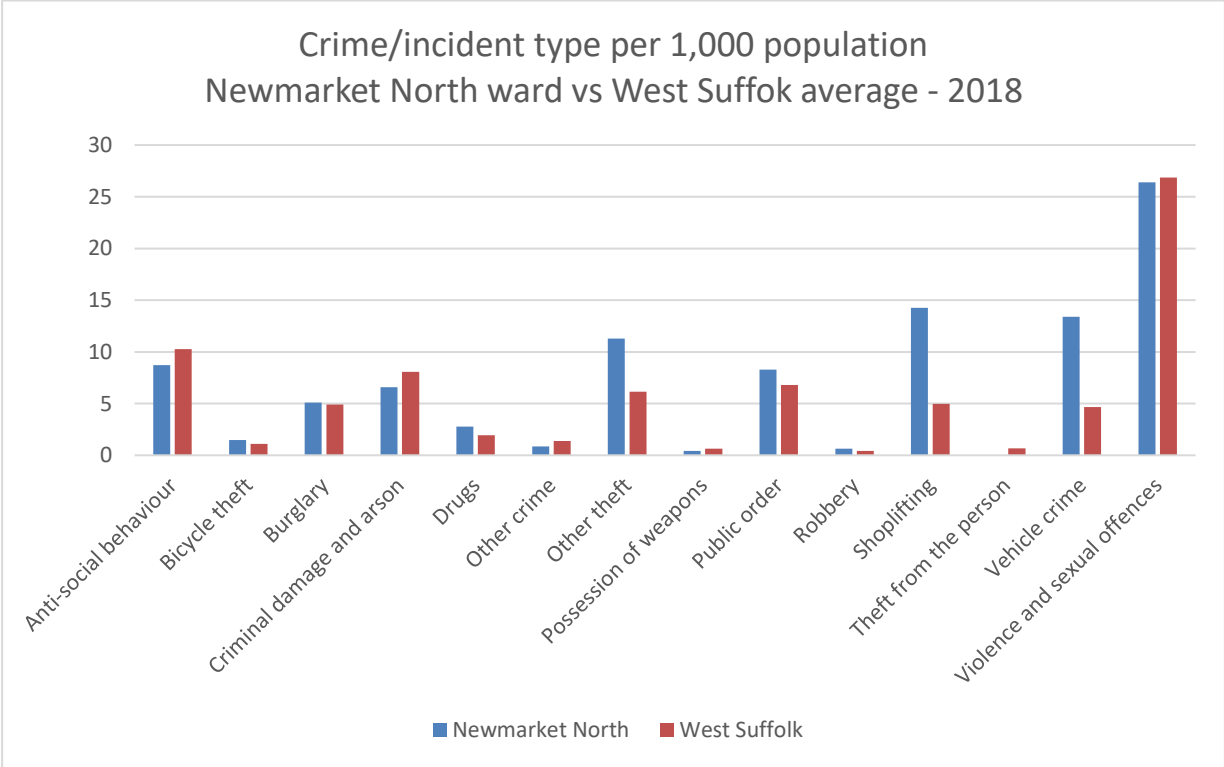

Health and lifestyle

Health:

The table below shows how the residents of Newmarket North ward regard their individual level of health.

Newmarket North ward ranks 12 out of the 43 wards of West Suffolk for the percentage of residents stating that they are in 'very good health' (with a ranking of 1 being the highest percentage of residents who state that they are in 'very good health').

Disability:

The table below shows the percentage of residents of Newmarket North ward who consider their day-to-day activities limited because of a health problem or disability which has lasted, or is expected to last, at least 12 months.

Newmarket North ward ranks 37 out of the 43 wards in West Suffolk for residents who consider they have a limiting long-term illness or disability that limits their daily activities a little or a lot (with a ranking of 1 being the highest percentage of residents who consider they have a limiting long-term illness or disability).
