**TOWN AND COUNTRY PLANNING (GENERAL PERMITTED
DEVELOPMENT) ORDER 1995**

**DIRECTION MADE UNDER ARTICLE 4(1) TO WHICH ARTICLE 5(4)
APPLIES**

WHEREAS the Council of the District of Forest Heath being the appropriate local planning authority within the meaning of article 4(6) of the Town and Country Planning (General Permitted Development) Order 1995 are satisfied that it is expedient that development of the description set out in the Schedule below should not be carried out on land adjacent to Long View, Bridge End Road, Red Lodge, Suffolk, shown edged red on the attached plan, unless permission is granted on the application made under Part III of the Town and Country Planning Act 1990,

AND WHEREAS the Council consider that development of the said description would be prejudicial to the proper planning of their area and would constitute a threat to the amenities of their area and that the provisions of paragraph 4 of article 5 of the Town and Country Planning (General Permitted Development) Order 1995 apply,

NOW THEREFORE the said Council in pursuance of the power conferred on them by article 4(1) of the Town and Country Planning (General Permitted Development) Order 1995 hereby direct that the permission granted by article 3 of the said Order shall not apply to development on the said land of the description set out in the Schedule below.

THIS DIRECTION is made under article 4(1) of the said Order and, in accordance with article 5(4) shall remain in force until 26 August 2009 (being six months from the date of this Direction) and shall then expire unless it has been approved by the Secretary of State for Communities and Local Government.

SCHEDULE

- (a) the erection, construction, maintenance, improvement or alteration of ~~any gates, fences, walls, or other means of enclosure~~ under Schedule 2, Part 2, Class A;
- (b) the storage of any caravan under Schedule 2, Part 4, Class B to the said Order and not being development comprised within any other class;
- (c) * ~~the use of the land as a caravan site as referred to in paragraphs 2, 7, 8 & 9 of Schedule 1 to the Caravan Sites and Control of Development Act 1960 to the said Order and not being development comprised within any other class.~~

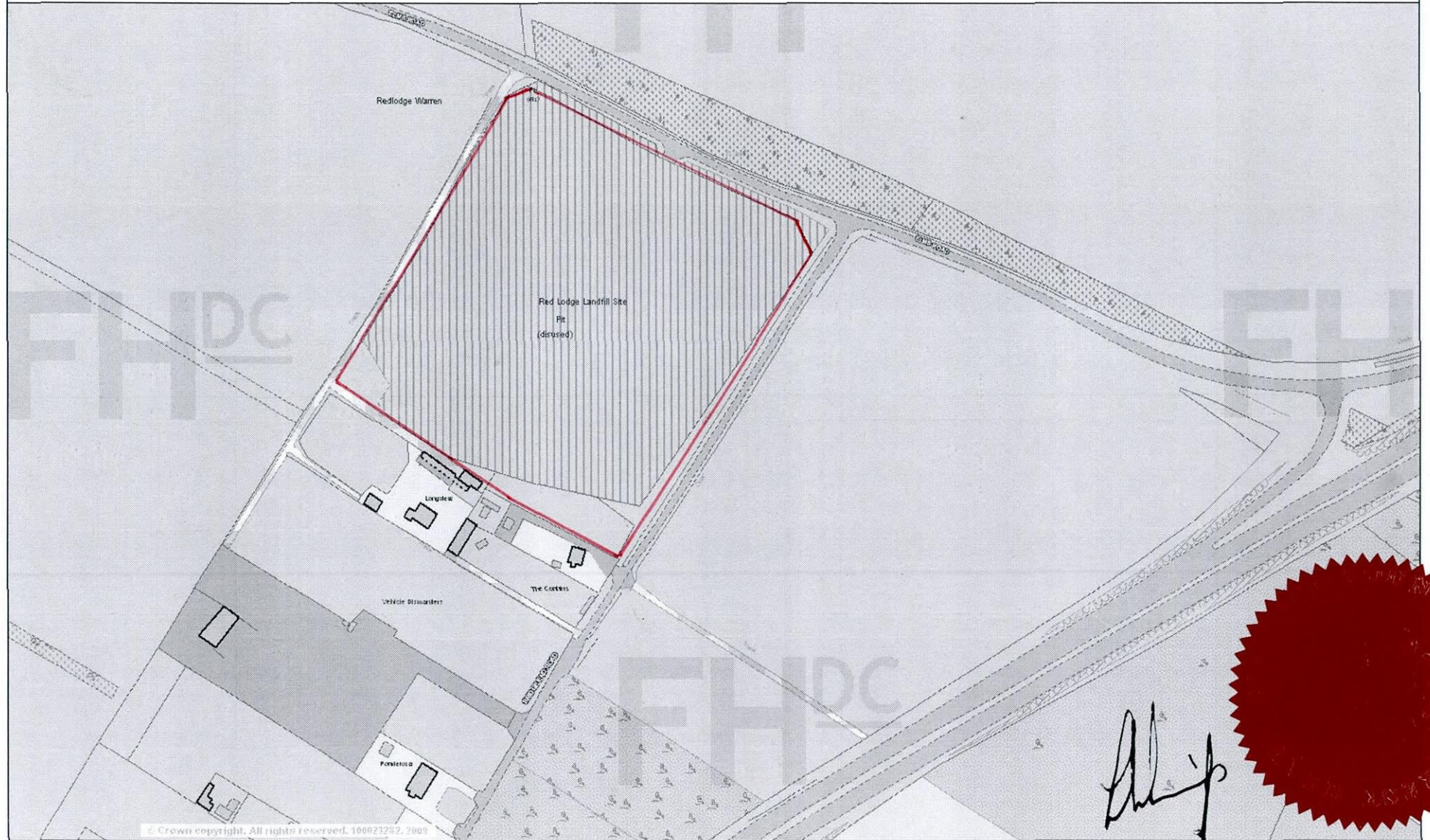
