W H E R E A S the County Council of the Administrative County of West Suffolk being the Local Planning Authority for the said County are satisfied that it is expedient that the erection or placing of moveable structures being development of Class IV.2. specified in the First Schedule of the Town and Country Planning General Development Order 1950 should not be carried out on the lands shown edged pink upon the map annexed hereto unless permission is granted on an application in that behalf under the provisions of the said order.

N O W T H E R E F O R E the said Council in pursuance of the powers conferred upon them by Article 4 of the Town and Country Planning General Development Order 1950 hereby direct that the permission granted by Article 3 of the said Order shall not apply to development of the said Class IV.2 and not being development of any other Class on the said lands.

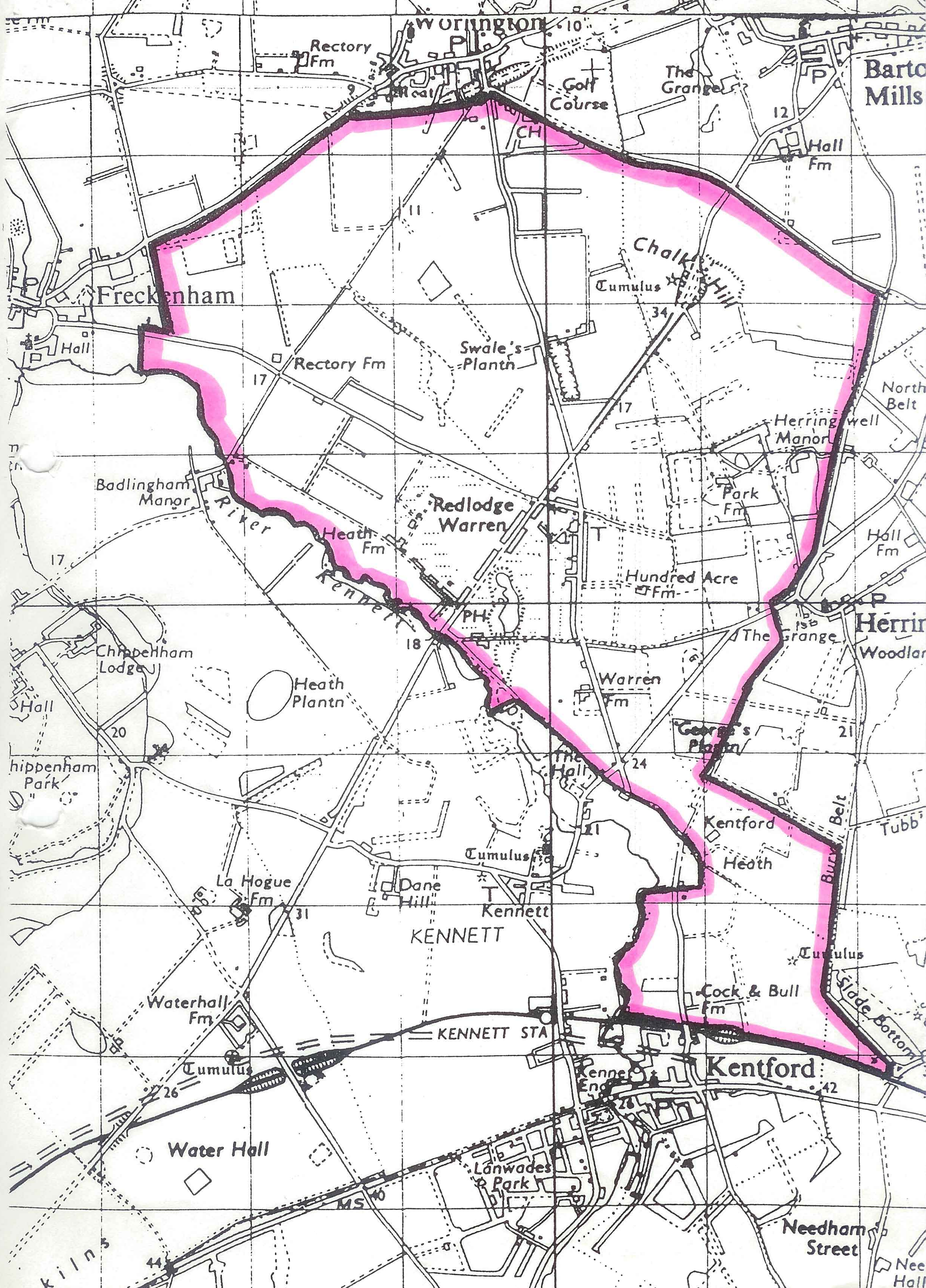
